

Walker County Swine Tag-In Instructions

Tag in is from 4:30 – 7:00 pm, Thursday, December 8, 2011 at the Walker County Fairgrounds.

Please fill out **one Livestock Entry Form per child** tagging in barrows.

Please fill out **one Barrow Show Form per child** tagging in barrows.

If more than one member of a family is eligible to exhibit barrows, then the family may tag as many alternate (family) barrows as there are exhibitors. (Immediate family only). *For example: The Brown family has two exhibitors. They must tag at least one barrow in each exhibitor's name. Then they may validate two more barrows in the family name, and either exhibitor may show either of these alternate barrows.*

To validate alternate family barrows, please fill out an additional **Barrow Show Form** and use your Family Name.

Take forms to Livestock Office to pay. Please have money ready and make checks payable to Walker County Fair Association. You only need one **Livestock Entry Form** per child so if you have alternate family barrows being validated, just split the numbers between the exhibitors so that you pay for the total barrows being tagged in.

You will then take **Barrow Show Form(s)** to Swine Committee members for tag in. You must have paid first.

Exhibitors are to accompany their swine. If the exhibitor cannot be present at tag-in we must have a letter signed by the exhibitor with an explanation of their absence.

Each exhibitor should be prepared to show ownership if requested.

We are hoping that having forms filled out ahead of time will make this process go smoothly.
